The Second Interim budget report is a snapshot in time of the District's financial health based on revenue and expenditure projections for the current fiscal year as well as a projection of the two subsequent fiscal years. It is a time to adjust the budget based upon the enacted State Budget and subsequent trailer bills, actual enrollment, and other factors that affect revenue and expenditures as of January 31, 2017. The Second Interim report covers the period from July 1 through January 31 each fiscal year and incorporates any changes that occurred after October 31, 2016. The report reflects the Original Budget (June 2016 Column A); the Board Approved Budget (First Interim 10/31/16 Column B); Actuals to Date - actual receipts and expenditures as of 1/31/17 (Column C); the Projected Budget (Second Interim 1/31/17 Column D); the difference between the Board Approved (First Interim) and the Projected Budget (Second Interim), and the percentage of difference. Also included is a summary report showing the major revenue and expenditure classifications for both the Board Approved Budget (First Interim) and the current Projected Budget (Second Interim), which are separated by unrestricted and restricted programs accordingly. Every major classification has an explanation attached that identifies the major components of the budget change.

The Second Interim includes changes in Multi-Year Projections based upon the 2017/18 Governor's Budget proposal released on January 10, 2017. The Governor's Budget proposal reduced revenue projections, lowered the gap funding percentage for the Local Control Funding Formula barely covering the cost of the projected COLA, and includes a 27% cash deferral of the June apportionment to July.

REVENUES

The increase in revenue is due to an increase in the interest earned on the General Fund.

EXPENDITURES

The increase in expenditures is due to the change in the custodial position and the purchase of window coverings.

TRANSFERS

The changes in Transfers out from First Interim to Second Interim is due to the anticipated transfer to the Cafeteria Fund being reduced because the expenditures to date are not as high as originally budgeted.

ENDING BALANCE

The Ending Balance on 6/30/17 is projected to be \$591,724.95. The decrease in the ending balance is due to the increase in expenditures for the custodial position and the purchase of window coverings.

DEFICIT SPENDING

The District is projected to deficit spend \$113,218.83 in 2016/17, \$34,997 in 2017/18, and \$45,447.00 in 2018/19. The projected deficit for 2016/17 is due to budgeting to spend the entire EIA carryover balance from prior year.

CHARTER SCHOOL FUND

The Charter School Fund has a beginning balance of \$28,340.55 and will be utilized to cover the 11/12 and 12/13 audit finding repayments once the District is assured there will be no future activity in the Charter School Fund.

CAFETERIA FUND

The Cafeteria Fund is funded entirely by a General Fund Transfer. During 2016/17, the General Fund has budgeted to transfer \$3,000.00 for Cafeteria Fund operating costs. The Cafeteria Fund had a Beginning Fund Balance of \$5,483.10 and the Ending Fund Balance is projected to be \$1,973.10.

DEFERRED MAINTENANCE FUND

The Deferred Maintenance Fund is projected to have no activity during 2016/17 and an Ending Fund Balance of \$10.87.

SPECIAL RESERVE FUND

The Special Reserve Fund is projected to have an Ending Fund Balance of \$26,949.87, an increase from 2015/16 of \$250.00 due to interest accruing in the fund.

CAPITAL FACILITIES FUND

The Capital Facilities Fund is projected to have an Ending Fund Balance of \$15,465.17, an increase from 2015/16 of \$830.00 due to the receipt of developer fees and interest accruing in the fund.

SELF-INSURANCE FUND

The Self-Insurance Fund is projected to have no activity during 2016/17 and an Ending Fund Balance of \$398.46, an increase of \$4.00 due to interest.

Based upon the information presented in the Second Interim Report the District continues to meet the requirements of a “positive” certification. Therefore, I am recommending that the Board adopt a “positive” certification. The certification states “...this District will be able to meet its financial obligations for the current fiscal year and subsequent two fiscal years”. The current year Budget and Multi-Year Projections indicate the District will meet its obligations based on information available as of January 31, 2017. The assumptions used to make this recommendation are outlined in the Multi-Year Projections.

The estimated P-2 ADA for 16/17 and 17/18 is 6.65 which is 95% of the projected enrollment, however the Criteria & Standards rounds the decimal up to the next whole number, making it appear that ADA to Enrollment is projected at 100%. The Historical Ratio average referenced in 3A is inaccurate because during the 13/14 and 14/15 school years Independent Charter School ADA was included in the ratio.

The District's Salaries & Benefit ratio to Total Expenditures is outside of the historical ratio because at the end of the 14/15 school year a long time employee retired, the employee was replaced with a lower paid employee. The District also contracts for Administrative and Business Services thus reducing salaries and benefits but increasing other expenditures.

MPP Transition Planning Comparison









Base vs Supplemental/Concentration Allocation







Reserve Levels



Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. 2. The combined assigned and unassigned ending fund balances that are in excess of the minimum recommended reserve for economic uncertainties for each fiscal year identified in the budget.
3. A statement of reasons that substantiates the need for an assigned and unassigned ending fund balance that is in excess of the minimum recommended reserve for economic uncertainties for each fiscal year that the school district identifies an assigned and unassigned ending fund balance that is in excess of the minimum recommended reserve for economic uncertainties.

The governing board of a school district shall include this required information in its budgetary submission each time it files an adopted or revised budget with the county superintendent of schools.

Education Code Section 42127 (d)(1) requires a county superintendent to either conditionally approve or disapprove a school district budget if the district does not provide for EC 42127 (a)(2)(B) public review and discussion at its public budget hearing.
