The District enrolled 1 new student that was not expected at Budget Adoption, with the addition of 1 more student the projected ADA has been adjusted to reflect at 95% attendance rate for 14 students instead of 13 students. The additional ADA of this new student will carry forward to 23/24.

#### Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates the need for LEAs to file amended federal reports when their actual indirect costs vary from the estimated indirect costs on which the approved rate was based.
