2022/2023 First Interim Report

December 14, 2022

The First Interim budget report is a snapshot in time of the District's financial health based on revenue and expenditure projections for the current fiscal year as well as a projection of the two subsequent fiscal years. It is a time to adjust the budget based upon the enacted State Budget and subsequent trailer bills, the closing of the prior fiscal year, and other factors that affect revenue and expenditures. The First Interim report covers the period from July 1st through October 31st each fiscal year.

Columns A and B of the report show the revenues and expenditures as adopted by the Board on June 22, 2022 with the beginning fund balance adjusted to reflect the 2021/22 Unaudited Actuals which was approved by the Board on September 21, 2022. Column C lists the actual revenue and expenditures as of October 31, 2022. Column D is the projection of the actual revenues and expenditures through the end of the fiscal year for the First Interim reporting period. The Second Interim Report will be as of January 31, 2023 and will incorporate any changes that occurred after October 31, 2022.

REVENUES

The increase in revenue is due to an additional COLA adjustment to the LCFF of 6.28%; ongoing funding for the Expanded Learning Opportunity Program (ELOP) \$26,494; one-time funding for Arts, Music and Instructional Block Grant \$7,400; one-time funding for Learning Recovery Emergency Block Grant \$24,200; one-time ESSER/GEER learning loss grants \$6,578; and REAP funds for 21/22 & 22/23 \$6,548. The Expanded Learning Opportunity Program is

funded for three years and is to provide longer days and extra days for additional learning opportunities outside the regular school schedule, 22/23 is year two of the three year cycle. The Arts, Music and Instructional Block Grant funds must be spent by 6/30/26 and can be spent on art, music, instructional materials, increases in health insurance and/or PERS/STRS contributions, the district is required to adopt a plan outlining the planned use of the funds. The Learning Recovery Emergency Block Grant funds must be spent by 6/30/28 and can be spent on supporting instruction time, accelerating progress to close learning gaps, pupil supports, staff supports, training, counseling, meal programs, before and after school programs and additional academic services for assessment of pupil learning.

EXPENDITURES

The increase in expenditures is based upon planning to utilize the 22/23 allocation of \$50,000 for ELOP; \$7,400 for Arts, Music, Instructional Block Grant; and \$24,200 for the Learning Recovery Emergency Block Grant.

ENDING BALANCE

The Ending Balance on 6/30/23 is projected to be \$670,090.67. The decrease in the ending balance is due to all income and expenditures being balanced and carryover funds projected to be expended during the current fiscal year.

DEFICIT SPENDING

The District is projected to deficit spend \$150,648.05 in 2022/23, \$161,102.00 in 2023/24 and \$70,947.00 in 24/25. The projected deficit for 2022/23 is due to budgeting to spend the ELOP carryover funds, REAP deferred revenue, T/K planning deferred revenue, ESSER/GEER-ELO deferred revenue and the GASB 31 journal entry reflecting the fair market value of the cash in county treasury. The projected deficit for 2023/24 and 2024/25 is due to budgeting 5% increases in expenditures each year to reflect inflation for costs of goods and services and the GASB 31 journal entry reflecting the fair market value of the cash in county treasury.

CHARTER SCHOOL FUND (09)

The Charter School Fund was closed during the 21/22 fiscal year. Interest continued to accumulate resulting in a beginning balance of \$51.75 which has been transferred to the General Fund.

CAFETERIA FUND (13)

The Cafeteria Fund is funded entirely by a General Fund Transfer. During 2022/23, the General Fund has budgeted to transfer \$12,500.00 for Cafeteria Fund operating costs. The Cafeteria Fund Ending Fund Balance is projected to be \$2,662.95.

DEFERRED MAINTENANCE FUND (14)

The Deferred Maintenance Fund was closed during the 21/22 fiscal year. Interest continued to accumulate resulting in a beginning balance of \$.02 which has been transferred to the General Fund.

SPECIAL RESERVE FUND (17)

The Special Reserve Fund has a beginning balance of \$27,780.79, a decline of \$1,055.00 due to the fair market value of cash in the county treasury, resulting in a projected ending balance of \$26,725.79.

CAPITAL FACILITIES FUND (25)

The Capital Facilities Fund or Developer Fee Fund has a beginning balance of \$19,856.00; interest earned of \$150.00; a decline of \$911.00 due to the fair market value of cash in the county treasury; resulting in a projected ending balance of \$19,095.00.

SELF-INSURANCE FUND (67)

The Self-Insurance Fund was closed during the 21/22 fiscal year. Interest continued to accumulate resulting in a beginning balance of \$.69 which has been transferred to the General Fund.

Based upon the information presented in the First Interim Report the District continues to meet the requirements of a "positive" certification. Therefore, I am recommending that the Board adopt a "positive" certification. The certification states "...this District will be able to meet its financial obligations for the current fiscal year and subsequent two fiscal years". The current year Budget and Multi-Year Projections indicate the District will meet its obligations based on information available as of October 31, 2022. The assumptions used to make this recommendation are outlined in the multi-year projections.

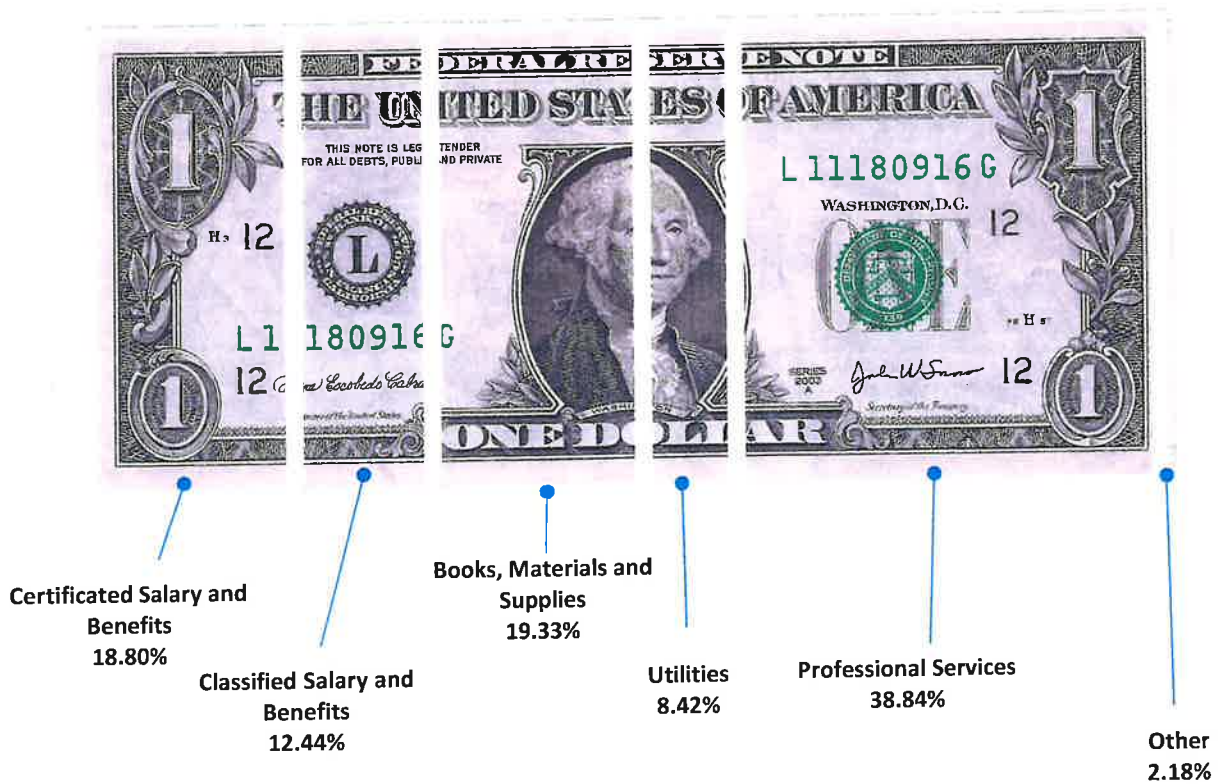
